

The Australian Institute of CPD Standards  
International Anatomy Award,  
sponsored by Miga

**Terms and Conditions**

1. Eligibility criteria - to be eligible for the 2026 International Anatomy Award you must:
  - a) Hold a current Miga (free) student insurance policy
  - b) Be currently enrolled as a 5th year undergraduate or 2nd year postgraduate student in a recognised AMC-accredited primary medical program. *(Students enrolled in recognised 6-year programs may apply either during their 5th year OR 6th year but not both).*
  - c) Demonstrate academic excellence and a clear interest in anatomy or academic medicine that aligns with future career aspirations
  - d) Embody a high standard of professional conduct with no record of academic or disciplinary misconduct
  - e) Be available for the full program duration ~11th Nov– 5th December 2026 (TBC) Hold a valid passport and meets [United Kingdom's travel requirements](#) which includes holding a current Electronic Travel Authorisation Visa
  - f) Be an Australian citizen or permanent resident
  
2. If awarded the 2026 of the International Anatomy Award, as a recipient you will:
  - o Be an ambassador for and advance the good name and interest of the Australian Institute of CPD Standards (AlcpdS) and the program sponsor, Miga during and after the program.
  - o You agree to provide updates about your experiences during the program and after for both the Australian Institute of CPD Standards and the program sponsor - Miga, the University of Cambridge, and Jesus College to use in promotional activities. The format of these updates will be agreed with you, but will include:
    - o 3 vlogs up to 1 minute each that cover:
      - o A day in the life at Cambridge University
      - o A day in the life as a Cambridge anatomy student
      - o A day in the life participating in extracurricular activities
    - o Photographs, videos, and other media including meetings with the University of Cambridge, Jesus College and potentially your university marketing/communications team

You must provide these updates and listed collateral as stated in a pre-agreed timeframe that will consist of before-during-after the program experience.

Updates will be in relation to:

  - o Your experience and what you have enjoyed
  - o How you have personally benefited from the experience; and
  - o How the experience will benefit your path in medicine from your acquired skills and knowledge
  - a. The content of the updates you provide may be edited by AlcpdS, Miga, University of Cambridge, or Jesus College for length and clarity. You agree that any collateral provided by you including your name may be published and may otherwise publicise the benefits of the International Anatomy Award.
  - b. You acknowledge that any content you provide as part of your participation in the program may be collected and managed through a third-party platform engaged by AlcpdS, Miga, University of Cambridge, or Jesus College.
  - c. The 2026 International Anatomy Award is scheduled to commence 11<sup>th</sup> November 2026 – 5<sup>th</sup> December 2026, and you must provide to AlcpdS signed evidence of acceptance into your proposed program prior to 1<sup>st</sup> September 2026.
  
3. You accept that you will undertake your travel and training program at your own risk and AlcpdS, Miga, University of Cambridge, or Jesus College accepts no responsibility or liability arising directly or indirectly from you undertaking this awarded program.



4. The International Anatomy Award program may be postponed, rescheduled, modified, or cancelled due to circumstances beyond the reasonable control of the Australian Institute of CPD Standards (AlcpdS), including but not limited to geopolitical conflicts, natural disasters, significant safety concerns, supply chain disruptions, or any other events deemed unforeseen. If the program experience is postponed, you acknowledge that:
  - a. If the program is postponed, AlcpdS will make reasonable efforts to reschedule the program to a later date, and the recipient will be notified as soon as practicable of the new proposed dates.
  - b. If the program is cancelled, AlcpdS will not be responsible or liable for any additional costs or losses incurred by the recipient.
5. Receipt of the International Anatomy Award does not constitute any partnership, trust, agency, joint venture, employment relationship, or student enrolment with AlcpdS, Miga, University of Cambridge, or Jesus College.
6. You agree to take reasonable care and diligence to ensure your conduct does not infringe upon AlcpdS, Miga, University of Cambridge, Jesus College, or any other party's intellectual property rights or bring any of the above-mentioned names into disrepute.
7. You must abide by the decisions of AlcpdS in relation to offers of the International Anatomy Award program.
8. AlcpdS, in consultation with the program sponsor, Miga, reserves the right to determine and allocate the 2026 International Anatomy Award at its sole discretion. Any decision of AlcpdS and Miga is final and is not subject to any right of appeal or reconsideration.
9. AlcpdS may retain your application and any supporting documentation, and it shall not be returned to you. However, all information provided will be retained in accordance with AlcpdS' Privacy and Cookies Policy, which can be accessed on our website at [AlcpdS.org.au](https://www.alcpdS.org.au).
10. You must ensure that your application form and any supporting documentation is received by AlcpdS no later than Friday, 31 July 2026.
11. You must not have previously been a recipient of the AlcpdS International Anatomy Award.
12. You must not be a contractor or supply services to either AlcpdS or Miga at the time of application.
